WE OPERATE CAMPS AT LOCATIONS IN 5 STATES, SERVING CHILDREN AND TEENS FROM 37 STATES AND 5 COUNTRIES. OUR ONE-WEEK, OVERNIGHT SUMMER CAMP AND YEAR-ROUND EFFORTS HELP TO REFRAME THE EXPERIENCE OF GRIEF AND EQUIP KIDS WITH INVALUABLE COPING SKILLS THAT ENABLE THEM TO MOVE FORWARD WITH THEIR LIVES. DUE TO THE COVID-19 PANDEMIC IN 2020, WE WERE UNABLE TO OPERATE OUR IN-PERSON CAMP BUT WERE ABLE TO CONNECT 1,000 CAMPERS THROUGH VIRTUAL PROGRAMMING.
